

Pest Control Request for Quotes

The GPMTD is requesting quotes for Pest Control Services to control pests for its three (3) facilities, all transit coaches, support vehicles and ADA vans.

The term of the contract shall be for a period of one (1) year beginning August 7, 2020 and ending on August 6, 2021 with an additional two (2) one-year options for the periods August 7, 2021 through August 6, 2022 and August 7, 2022 through August 6, 2023.

● **Scope of Work**

- 1) Furnish all materials and labor necessary to control all forms of pests including but not limited to roaches, ants, spiders, rodents, and all types of crawling insects/animals for three (3) buildings, fifty-three (53) transit coaches and five (5) paratransit (ADA) vans.
- 2) The service shall include thorough treatment of all GPMTD buildings located at 2105 NE Jefferson Avenue, Peoria, IL and the Transfer Center located at 407 SW Adams Street, Peoria, IL. Including all (53) buses and (5) paratransit / supervisor vans. The following is an example of the schedule of treatments that include late night and early morning hours on weekends.
 - 6:00 am Saturday spraying all buildings including hallways, common areas, office areas, closets, bathrooms, and etc. The technician will be escorted and given access by a Citylink employee. Included in this treatment spraying the inside of all buses and supervisor vehicles. This will occur once a month. The Saturday will be agreed upon after contract is awarded.
 - An inspection will be conducted at least 14 days from the treatment date to confirm monthly treatment was effective and perform additional treatment where necessary. Also traps will be checked for animals and critters during this inspection. All regular treatments that are necessary between regular scheduled services shall be free of cost to GPMTD.
 - A quarterly treatment for bed bugs on all (53) buses and 5 (supervisor) vehicles will be included in this service agreement. Due to dwell time for this service, it will be conducted late evening on weekend night. The day and time to be agreed upon after contract is awarded.
 - Semi annual treatment for spiders is required. One treatment in the late Spring and the other treatment early fall. The interior and exterior will be treated where spiders are likely to be present.
- 3) The successful vendor shall furnish GPMTD with a written statement at the time of each service describing what precautions personnel must take to be safe, and signed off on by the Technician who completed the work. A physical (paper) notice must be rendered on the day of service **or** by email to the Director of Maintenance within 72 hours of service.
- 4) The successful vendor shall furnish GPMTD a complete set of SDS sheets of all chemicals it uses on the property and vehicles.
- 5) All invoices must show what particular services were completed for that billing period/invoice.
- 6) Contract will not renew automatically at the end of the term.
